Seven ways to make a report to our ethics hotline



/ Talk to us

Most reports are made via our **live answering service**. Use the dedicated Whistle Blowers hotline number for the organisation concerned to reach our information centre.



Start a conversation by WhatsApp or SMS

Send us an SMS to 33490 if you are in South Africa (cost R1.50), or WhatsApp us from anywhere in the world on +27 (0) 71 868 4792. We can call you back.



Download and use the Whistle Blowers App

Download the secure Whistle Blowers app from Google Play or the Apple App Store. The App guides you through the reporting process with ease.



Use our online web form

Visit our website online at www.whistleblowing.co.za where you will find an online reporting platform into which you can make your submission.

Downloading the Whistle Blowers App



Ensure your smartphone or tablet is enabled with Google play or Apple App store for the Whistle Blowers App to be fully functional on your device.



From a Home screen, tap App Store.

To browse the App Store, tap Apps (at the bottom).

Scroll then tap the Whistle Blowers icon. Tap the app.

Tap GET then tap INSTALL.

If prompted, sign in to the iTunes Store to complete the install.



Open the Google Play Store app. You can also go to play.google.com.

Search or browse for the Whistle Blowers app.

Select the icon. Tap Install.

Follow the on screen instructions to complete the transaction and get the content.

Download the App now, whether you want to make a report immediately or in case you would like to in the future.

Start using the Whistle Blowers App



Remember! This App is only for reporting unethical activity in a company, business or organisation that subscribes to the Whistle Blowers ethics Hotline.



Once the app has successfully installed on your device, tap the icon and you will be directed to the Whistle Blowers reporting app home screen.

Now just tap the whistle to continue.

Do not worry – no information you enter will be received by us until you have completed a report and decided to submit it!

Start your description of the matter

CO4 DESCRIBE THE MATTER

Please describe the unethical activity you wish to report **in as much detail as possible** (What, When, Who, How).

The more information you provide the easier it is for an investigation to be successful. There is no limit on the amount of text you can enter.

Most of your time making a report will involve describing the suspected or actual unethical activity.

Start by explaining the situation in as much detail as possible. There is no limit to the amount of text you can insert on this screen.

But no need to fear! On the next screens we will ask you specific questions that will help you be confident that your report is complete.

Our code name facility and the unique reference number we allocate to anonymous reports makes it possible for you to follow-up on a report made without giving us your name or contact details.

We write reports that are strictly edited to remove information that could reveal your identity and this anonymization process is subject to a stringent quality control system.

It might be obvious to you but not to those who are responsible for investigating your report. Please help us understand how the matter can be best investigated.

For example: Where, how and when can evidence be found?

You may also use this section to provide any other relevant information. There are no text limitations.

Once complete, you are nearly done!



Submit your report



You've come to the end of the reporting screens, but on reflection do you wish to add any further information?

This is your chance to **go back** and edit or add to any information you have already entered.

All done? Just tap the whistle to submit your report – and rest confident that it will be received immediately by a trained information agent at our 24/7 information centre.



You will now receive confirmation of your report submission...

... and a unique report reference number for you to store safely together with your code name.

You should use this reference number and your codename or password if you wish to add information or evidence or follow up on your report. You can do this by contacting the organisation's dedicated hotline number either anonymously or in strict confidence.
